On this project, McVAC utilized the Hy-rail Jet / Vac Combo Truck to clean existing 36" to 48" reinforced concrete pipe runs along / beneath the railroad tracks as directed by the General Contractor. Water was decanted from the debris body, and subsequently the solids were transported off-site for disposal.

**McVAC Custom-built Hy-rail Jet / Vac Combo Truck** – the truck operates on-road and on-rail. It includes: 17 CY debris tank; 2,000-gallon water tank; 300 GPM jet pump for heavy cleaning / large debris removal; 1000' of 1" or 1 ½" hose, or 500' of ½" hose; double "sled heads" for wide pipes / culverts; decanting containers to return water; a wide variety of cleaning nozzles / tips; and on-board water recycling for enhanced on-rail productivity. The truck is also licensed to transport non-HAZ & RCRA waste off-site
